ABOUT MTAA



MTAA represents manufacturers and suppliers of medical technology (MedTech) used in the diagnosis, prevention, treatment and management of disease and disability. MTAA members supply the majority of non-pharmaceutical products used in the treatment of disease and disability in Australia.

The range of MedTech is diverse, from familiar items such as syringes, wound dressings and wheelchairs through to more complex technologies such as pacemakers, magnetic resonance imaging (MRI) machines, hip replacements, robotic surgery equipment and remote monitoring devices.

Our members play a vital role in providing healthcare professionals with essential education and training in the use of the more complex medical technologies to maximise patient health outcomes from the use of that technology. Industry-sponsored fellowships and funding for research and development in hospitals, universities and research facilities help ensure the development and commercialisation of medical technology meets contemporary healthcare needs and improves patient health and quality of life outcomes.

Associate members of MTAA are supporter or partner organisations and individuals who support the work of the industry along the entire MedTech value chain, from product idea through to patient utilisation. And we are especially pleased to see the commitment from State Governments to reduce the elective surgery waiting lists so that patients can get faster access to life-changing procedures.

As we look forward into the next financial year, I am pleased to say MTAA continues to go from strength to strength, guided by our Strategic Plan. Members can be assured that our industry body is ready to champion their policy priorities into the next year and beyond.

MESSAGE CEO REPORT

This year has seen MTAA, its committees and forums deliver on the most ambitious and comprehensive policy and advocacy agenda in the association's history. Our team and our members have worked around the clock to develop and launch multiple key reports central to the Australian MedTech industry's key policy priorities.

The efforts of members, and non-members alike, have enabled MTAA to continue its positive collaboration and working relationship with the new government, ensuring the key areas of reform important to our stakeholders didn't miss a beat through the change of administration.

The re-launch of MTAA's MedTech on the Hill initiative in June was an outstanding success that saw members, health sector partners and Members of Parliament come together in Parliament House to get hands on with some of the latest and greatest medical technologies improving and saving lives. MTAA was also pleased to have secured the Minister for Health and Aged Care, the Hon Mark Butler MP, to deliver the keynote address at the launch of the Value of MedTech Report, coinciding with the MedTech on the Hill evening event to showcase the latest MedTech and its real and lasting impact on improving patient lives.

Over the past year our team has harnessed the interest and activity in digital health. We hosted a Cyber Security Symposium in May – another sell-out event – alongside the development of our Digital

Health report. With the support of the Digital Health Advisory Group, the association has been busy promoting the rationale for greater government attention on developments in this critical space.

The end of this financial year brings with it a strong financial position to our association. We have managed to deliver this while keeping the fee increases well below inflation. This gives us more capacity and flexibility in our policy, advocacy and events activities than ever.

Member Focus

A total of 113 members are currently working with MTAA. This includes 81 full members and 31 associate members. We welcomed 4 new industry members this year: EBR Systems, Endotherapeutics, Eudaemon Technologies and Field Orthopaedics. We also welcomed 5 new associate members this year: Amazon Web Services Australia, Expeditors International, Heng & Hurst, Pulse Economics, and Value-Based Access.

There are 9 committees currently operating with 121 positions. The 2022/23 committees are Public Affairs, Industry Policy, Reimbursement, Regulatory Affairs, Code Authority, Code Monitoring, Finance, Women in MedTech and the MedTech Conference Committee. Our sincere thanks to our members for their ongoing contribution to our committees, which is critical to our success.



Financial Performance

Total revenue grew by 19% in the twelve months to 30 June 2023 (FY23). This was primarily a result of a rebound in professional development and face-to-face-events, and growth in membership and grant income.

Total expenses increased by 20%, partly reflecting the increased professional development and events activity and also due to MTAA's investment in additional resources to drive key strategic initiatives in FY23: the Value of MedTech Report and the progression of MTAA's digital health and value-based procurement activities.

As a result, MTAA achieved a small net profit of \$13,104 for the twelve months to 30 June 2023 compared with the previous year's profit of \$28,710.

MTAA's balance sheet reflects a strong financial position with net assets of \$2,064,826, which is an increase of 41% over the last five years.


Conclusion

POLICY, ADVOCACY & COMMUNICATION

MTAA has continued its core advocacy activities guided by the Public Affairs Committee's Key Strategic Advocacy Pillars:



Value of MedTech;



A Partner in Health; and



Sustainable Access to MedTech.

The development of MTAA's Key Strategic Advocacy Pillars delivers for industry a forward advocacy plan for the duration of this Parliament, and beyond, guiding the activities of MTAA members and the broader industry by focusing on the policy priorities set out by the Board's Strategic Plan, and engaging with the stakeholders key to delivering on industry's commitment to patient access and doctor choice in the private health system.

Simultaneously MTAA has also continued its engagement with the new Federal Government for positive Prostheses List Reform that abides by the guardrails set out in the signed Agreement with the

Government. Underpinning this engagement was MTAA's success in securing a pre-election commitment from the future Labor Government to deliver on the Agreement while in office.

MTAA's productive relationship with Senators and Members of Parliament can best be seen through the continuation of the Parliamentary Friends of MedTech group, now chaired by the chair and deputy chair of the House of Representatives Standing Committee on Health, Aged Care and Sport, Dr Mike Freelander MP (Labor), and Melissa McIntosh MP (Liberal).

Over the past 12 months, MTAA has also continued to advocate for member-specific matters at the ministerial, parliamentary and committee levels of government, ensuring MedTech's voice is heard and included.

This year also saw the relaunch of the MedTech on the Hill initiative in Canberra, providing members face-to-face meetings with more than 40 MPs and Senators from across the political spectrum to discuss the economic and social contributions of MedTech in Australia.

Successfully engaged with TGA to prevent proposed changes to clinical trial notification that would have increased regulatory burden and cost.



Developed and launched the Value of MedTech Report, exploring the social, economic and health benefits to wider Australian community.



Pre-Budget Submission – successfully securing TGA funding of \$61 million in the Federal Budget for public good issues.

Successfully advocated for changes to the PL Compliance Strategy making insurer obligations to pay clearer.



Developed the MTAA Digital Health Report aimed at identifying opportunities for digital health uptake and barriers that need to be overcome.



Secured a seat at the National Reconstruction Fund table to participate in the Government's Medical Sciences Industry Working Group.



Collaborated with MTPConnect, on the CTCM Program delivering \$7.2 million investment into MedTech start-ups.




Attracted 376 attendees to first in-person MedTech Annual Conference since 2019.



Launched Edition 13 of MTAA Code of Practice, with 3,560 students completing the Code program via user-friendly new platform.





During FY23 the majority of the two major focuses was on Prostheses List (now renamed the Prescribed List) reforms due to the intensity of the consultation process, and the promotion of MTAA's '7 Point Plan' for private health insurance reform, which included:

- 1. Force insurers to return 100% of COVID-19 profits to members,
- 2. Require insurers to pay out a minimum of 90 percent of their revenue to members,
- 3. Establish a Private Health System Regulator to develop a reform agenda to increase sustainability and protect patients,
- 4. Refuse premium increases for insurers whose claims ratio is below the industry average,
- 5. Prevent insurers from providing rebates for unproven treatments,
- Standardise rebates for services across insurers to streamline administration and provide for certainty for consumers, and
- 7. Hold an inquiry into insurers to identify opportunities to reduce management expenses.

MTAA's Reimbursement Committee provided and facilitated responses to 13 Prostheses List-related consultations on topics covering:

- Legislative changes
- Bundling and removal of General Use Items
- Benefit group consolidation
- PL criteria
- Compliance obligations
- Post-listing review framework
- New listing system (Health Product Portal)
- Application pathways
- Cost recovery

In addition, MTAA had multiple meetings and communications with the Department of Health's Prostheses List Reform Taskforce to put the industry case and to better understand the proposals from the Department.

MTAA also supported submissions and communication by its Cardiac Forum on cardiac service costs, the Neuromodulation Forum, and the Biomodels and Surgical Guides working group on post-listing reviews. MTAA also worked closely with other stakeholders including hospitals, clinical and patient groups on reforms.

Throughout these consultations, MTAA's aim was to ensure that the Memorandum of Understanding for PL Reform signed with the previous government was consistently honoured. Better outcomes in PL reform included:

- Clearer process and pathway for listing nonimplantable devices on Part C
- Commitment of Department to a simpler listing pathway (Tier 1) and focused HTA (Tier2b)
- Pause on regrouping to avoid unintended consequences and adhere to MOU
- One year pause on introduction of cost recovery levy
- Significant changes to the Health Products Portal including removal of unnecessary benchmark pricing requests
- Reasonable interim outcome for reductions in Cardiac Implantable Electronic Devices
- · Delay on removals of General Use Items from the PL
- No implementation of proposed public price maximum benchmark for new groups
- Pause on listing devices by systems
- Greater recognition of insurer obligations in Compliance Strategy

During this time, MTAA also participated as an advisor on the Prostheses List Advisory Committee, allowing it to provide the industry perspective to PL listing decision makers.

In other reimbursement areas, MTAA engaged the Department on the Health Technology Assessment Review advocating for device inclusion and provided a submission to the first round of consultation.



Regulatory Affairs

MTAA has continued to provide significant support and insights to members navigating the regulatory affairs environment. MTAA's services enables members to access important information and opportunities for input into the changing regulatory landscape, allowing for a platform to promote better patient access or harmonisation with government, agencies and other stakeholders.

Highlights of 2022-23 include the following:

- Successfully engaged with TGA to prevent proposed changes to clinical trial notification that would have increased regulatory burden and cost.
- Conducted several successful pre-market and post-market workshops in collaboration with TGA in Sydney and Melbourne.
- Contributed to the publication of 6 MDR guidance documents for industry.
- Continuous growth of the Regulatory Forum reaching over 100 members providing access to insights that would not easily available.
- Partnering with TGA to create trusted working groups on key issues driven by members.
- Continuous and ongoing partnership with Standards Australia
- Monthly 1:1 calls with senior TGA staff and MTAA to discuss member issues and priorities.
- Hosted the members-only FDA & UK MHRA networking event offering direct Q&As with the regulators.
- Hosted Global MedTech Alliance (GMTA) dinner with Pathology Technology Australia (PTA) at the International Medical Device Regulators Forum (IMDRF) meeting.









Digital Health

One of MTAA strategic areas of activity in 2023 was to lead the policy discussion on the future of digital health in Australia and its power to transform the way we think about and interact with healthcare.


While the move toward digital health was already occurring, its exponential development required a strategic approach from industry. Tunstall Australia's Lyn Davies established and led the Digital Health Advisory Group (formerly the Connected Health Advisory Group), to raise awareness, champion thought leadership (advocacy and engagement), and progress reimbursement issues of the digital health matters.



Digital Health White Paper

In line with its strategic priority, MTAA appointed a full-time resource solely dedicated to advancing the industry's digital health related activities. The additional resourcing helped develop the digital health white paper by exploring the barriers and opportunities for digital health uptake in the MedTech industry. Furthermore, the paper provides recommend policy solutions to address specific digital health gaps facing MedTech. The MTAA digital health report "Digital Health: Breaking barriers to deliver better patient outcomes" is to be the core collateral used to shape digital health advocacy for the upcoming FY23-24 period.

As part of the research approach, a MTAA Digital Health Survey was developed and ran throughout March and April 2023. The survey was open to all Australian MedTech organisations with a total of 51 completed responses, 40 Unique organisations, from 32 MTAA member and 8 non-member companies. Five key digital health topics were identified and became the core themes of the report: Health data, Cybersecurity, Interoperability, Regulation of digital health and reimbursement & procurement of digital health products & services. The report was completed in late FY22-23 and preparations for the launch and corresponding launch event for the report well underway with a scheduled launch in early FY23-24.



Cyber Security

MTAA, with the support of its new Cyber Security Working Group (CSWG), is bolstering the MedTech industry's position as a leader in cyber security. Through stakeholder engagement with relevant government bodies (TGA, ACSC, and State Governments) and structured partnerships across the health and cybersecurity sectors, MTAA has facilitated the development of improved practices, and policy development of healthcare-based cyber security.

Throughout the past year, there has been significant work on numerous cyber security topics of interest including the development of a Cyber Security Fact Sheet, responding to the 2022 List of Critical Technologies in the National Interest consultation, review of the Optus & Medibank cyber breaches, considered cyber security in tendering, provided input into the MTAA Digital Health Survey and Report, and discussed Artificial Intelligence (AI) and ChatGPT's place within MedTech.

A key activity for the year was the hosting of a Cyber Security Symposium on 30 May 2023 bringing together government, industry, and consumers to reflect on the cyber security and privacy issues within the healthcare landscape. The sold-out Sydney based in-person event was led by CSWG Chair, Paul Davies, Abbott's Director for Government Affairs Australia/New Zealand and included numerous CSWG Group members in the day's proceedings. Commencing with a keynote from Dr Ian Opperman, Chief Data Scientist - NSW Government, the day had a mix of panels and speakers with a variety of discussion covering a broad array of cyber related topics and issues.

Educating and Socialising Digital Health

MTAA addressed numerous other pertinent digital health related issues throughout FY22-23. A connected health fact sheet was developed: "Addressing the Need for Connected Healthcare in Australia" and several consultation responses developed. The Digital Health Advisory Group reviewed digital health-specific issues covered in the critical infrastructure bill. They also provided input into MTAA's response to the Privacy Act Review to the Attorney-General's Department.

MTAA also submitted a response to the Australian Digital Health Agency's (ADHA) Draft National Digital Health Strategy 2023-2028 and associated Delivery Roadmap. In conjunction with APACMed submitted a response to the Artificial Intelligence (AI) discussion paper out for review by the Minister for Industry and Science "Safe and Responsible AI in Australia".

The increased MTAA focus on digital health also led to increased engagement of key stakeholders including re-engagement with the Australian Digital Health Agency (ADHA) and various sections within the Department of Health.

Industry Development

One of MTAA's priority strategic areas of work is focused on nurturing Australian innovation and supply chain resilience. This involves developing an innovative eco-system for commercialisation. In addition, MTAA will advocate for Australia-wide planning for the next disruptive event and ensure access to critical technology at that time.

MTAA, with the guidance of the Industry Policy Committee (IPC), has undertaken a diverse range of activities in the last financial year. The most notable of these has been managing the development of the Value of MedTech report. Significant work has also been progressed in the National Reconstruction Fund to better support start-up ecosystem, Value-Based Procurement Report, and leading industry discussions into the emerging integration of Environmental, Social and Governance (ESG) initiatives and prioritisation in Australia.

Value of MedTech Report

The Value of MedTech Report involved bringing together economic survey data and case studies to capture the true economic and social impact of the Australian MedTech sector. It is a major study that quantifies the difference the MedTech industry makes to the lives of Australian patients, the healthcare system and our economy.

As part of MTAA's annual MedTech on the Hill initiative, the Report was formally launched by the Minister for Health and Aged Care, the Hon. Mark Butler MP, in Parliament House during an event attended by Ministers, Members of Parliament, Senators, and key health sector stakeholders.

The Industry Policy Committee has been involved in bringing the report together, with members both directly involved as part of the Steering committee, which provided project governance, and/or as a contributors of survey data or case study material to the report.


National Reconstruction Fund

The National Reconstruction Fund (NRF) presented a significant opportunity to invest in manufacturing capabilities to establish fund settings that will address the current underinvestment and outflow of capital from MedTech. Working alongside the Industry Development Working Group and based on internal analysis of investment trends in the sector, MTAA responded to particular policy consultations to endorse the NRF and purposed investment into the start-up ecosystem of MedTech.

MTAA's continued engagement with the Department of Industry on the NRF resulted in being invited to join the NRF Medical Science Industry Working Group. The working group involves key industry and government stakeholders designing co-investment plans to identify high level opportunities to support investment in medical manufacturing.

Review of Privacy Act Report

In the first half of 2023, MTAA formed a privacy working group consisting of legal counsel and privacy specialists from member companies to develop an industry informed response to the Review of Privacy Act Review Report. This report outlined suite of proposed changes to privacy legislation impacting a range of industries including medical technology. Having successfully mobilised to address the Report's proposed reforms, the privacy working group can reactivated to address future privacy reforms or government consultation.







Industry Development





Clinical Trials

One of MTAA's strategic areas of activity in 2023 is to accelerate the translation of research prototypes to commercial models by advocating for more clinical trial activity in Australia, and, more importantly, develop strategies that can be implemented to enhance the clinical trial environment. MTAA is working closely with TGA, CT: IQ Clinical Trials, Clinical Trials Collaborative Forum (CTCF) and Clinical Investigations Forum (CIF) to raise awareness of and proactively address the issues affecting industry.

ESG and Sustainability

MTAA has continued to advance ESG as a focus area for the Australian medical technology sector. At the 2022 annual conference, MTAA organised a panel session bringing together medical waste solution providers, government and industry to discuss the need for industry to be pro-active in addressing changes around waste management and designing technologies that embed sustainability principles. In November 2022, MTAA hosted a webinar on the NHS supplier roadmap in late 2022 presented by the Association of British HealthTech Industries (ABHI). This was an informative session that highlighted the rapid changes in ESG requirements for public procurement process impacting British medical device suppliers – a potential indication of regulatory changes in Australia.

In the first half of 2023, MTAA created a sustainability working group to provide industry informed responses to future environmental regulations that may impact the healthcare system. With input from the working group MTAA, provided feedback to the Department of Health's National Health and Climate Strategy consultation workshops and submitted a formal response to the consultation paper in late June. The strategy will be the first climate-based strategy for the Australia healthcare sector and MTAA's response is part of a broader engagement approach to influence the development of the strategy.

Finally, during mid 2023, MTAA was an activity participant in the MedTech ESG working group organised by APACMed, the trade association for the Asia-Pacific region. MTAA provided insights on current sustainability activities impacting the Australian MedTech sector. These insights will form part of an ESG whitepaper that will focus on ESG trends across the MedTech sector at an APAC level.

Supply Chain

MTAA established a supply chain working group in the second half of 2022 in response to significant disruptions to medical technology supply chains during the pandemic. The group consists of supply chains directors and managers who update MTAA on emerging supply trends and challenges within the sector. As an additional activity, MTAA conducted a supply chain survey of members companies in August 2022, capturing key enablers, barriers and opportunities to managing supply chain challenges within the Australiana MedTech sector. This has been a useful resource to convey the sector's challenges when engaging the Department of Industry and increasing the profile of supply chain matters as a broader membership policy priority area.

Collaborative Partnership with Defence

MTAA assisted the University of Melbourne in delivering the inaugural Defence Meets MedTech symposium. MTAA and MedTech representatives joined in the discussion to uncover the role industry, defence and academia play in building sovereign capacities and expertise, engagement in co-design and co-development of novel technology, funding and investment in dual-use technologies and much more. This new initiative will result in a collaborative partnership with Defence and the goal to support a healthy innovation environment for novel technologies to flourish.

Member Communications

Digital media remains a strong communication outlet to educate, inform and persuade stakeholders within MTAA's orbit of influence. During the 2022-23, MTAA published 65 newsletters, including 24 Member Updates (exclusive member content), 41 full database mailouts – a significant increase on the previous year. Member feedback showed the quality of content this year greatly improved, with departments, committees and third parties providing a richer array of exclusive news, opportunities and insights.

LinkedIn showed strong increase with an additional 1,280 followers. Frequent content posting and commentary on relevant news aligned with MTAA advocacy priorities has resulted in more support for the channel and more interactions from the online community. Outside of direct contact, LinkedIn is a key medium to reach the boarder healthcare sector, advocate to a targeted and engaged audience, and an important outlet to promote MTAA and industry activities.

Active participation of members is essential to MTAA achieving success. This year saw 121 members and industry representatives join MTAA committees and more than 220 member and industry representatives contribute to the work of MTAA Committees, Forums and Working Groups.

MTAA Forums and Alliances provide opportunity for interaction between members and specific areas of interest affect Industry. A total of 9 active committees, 7 Forums, 5 Working Groups forms MTAA's governance supporting the key initiatives relevant to members.

This year, we saw the introduction of the Sustainability Working Group. As environmental

and social considerations become an increasingly important, members are looking into an industry wide approach to address sustainability challenges in healthcare. MTAA has also established the Supply Chain Working Group to focusing on medical technology supply chains resilience. Influenced by the disruptions experienced during the pandemic, this group focuses on identifying vulnerabilities in the MedTech supply chain, communicating these with Government and developing plans to prepare for future disruptions.

Events

MTAA leverages its connections and industry knowledge to provide keynotes and workshops to members and the wider MedTech community. The planning of these events is fed from committees and working groups aimed to educate and advocate on behalf of certain groups and industry topics and provides insights that are not publicly or easily available. Furthermore, these events facilitate networking with decision-makers, influencers and like-minded professionals to engage in industry specific discussions and encourage a supportive and collaborative approach to progressing initiatives and activities of MTAA.

In 2022-23, MTAA delivered 13 face-to-face and online events categorised into 3 formats: networking, workshops and webinar. This categorisation is designed to better fit the adoptive lifestyle of many working Australians, the advances and convenience of technology while in-person experiences made a resurgence. MTAA has also expanded its regulatory events in Melbourne and Brisbane providing better access for in-person learning, information sharing and networking.

Regulatory Affairs for Medical Devices Workshop 25-26 August 2022

In collaboration with TGA, this interactive workshop provided detailed coverage of the medical device regulations in Australia. More than 30 regulatory and MedTech professionals joined this two-day workshop building their knowledge of current regulatory terminology and procedures, with scenarios brought up by attendees to present their case on how to meet their regulatory requirements.

MedTech22 Annual Conference 6-7 October 2022 | Sydney

The MedTech22 Annual Conference brought together MedTech professionals from across industry, government and academia to discuss the key issues affecting industry. After a 2-year absence, this was the first major in-person event hosted by MTAA and the appetite for face-to-face was obvious with the conference selling out 2 weeks prior to launch. Twentytwo sessions took place with over 40 international and local presenters over the 2 days.

Day 1 of the Conference opened with Dr Jordan Nguyen, a leading Australian biomedical engineer, inventor and inspiring keynote speaker, who captured the imagination of the entire room. He highlighted the relationship between humanity and technology, what drives its evolution into the future, and shared heartfelt examples of how life-changing technology can transform the lives of vulnerable and disadvantaged Australians. Following his opening keynote, Dr Nguyen joined senior leaders in healthcare for a panel discussion on the transformation of healthcare post-covid, its critical role in Australian society and put to question the funding models, burnout and sustainability of the existing healthcare system.

The day continued with sessions on interoperability and how it can improve existing healthcare systems, an in-depth conversation with TGA looking into their thought-process to decision-making, closing the morning session was a one-on-one discussion with Sydney Local Health District exploring the challenges and lessons learned from integrating and using

medical devices in frontline health services during the pandemic. The afternoon sessions discussed MDR impacts on clinical studies in Australia, building a cyber community to protect healthcare, and closing the day featured a panel discussion on the benefits of implementing a reconciliation action plan for organisations.

The political update opened day two of the conference with Dr Mike Freelander MP and Melissa McIntosh MP sharing insights into how to best engage with Government while facing a dynamic political operating environment. For the first time publicly, MTAA and a local and international panel discussed the rise of ESG and sustainability requirements witnessed aboard, its increased adoption in Australia and the

work that is progressing corporate responsibility. As the day continued, the concurrent sessions took over with highlights including 2 PL reform discussions featuring the Department of Health, post-covid talent opportunities, the benefits to deeper engagement with the local innovation ecosystem, how private health insurance can support future models of care and much more. The day ended on an emotional high as the audience heard from product specialists and the patients they supported. They shared their story of how medical technology has impact their lives - a kind reminder for the many device suppliers in the room of how important their work is and the technology they provide to help patients around the world.









Australian MedTech Industry Awards 6 October 2022 | Sydney

Once again, the Australian MedTech Industry Awards brought together industry leaders to celebrate and pay tribute to a year of innovation and leadership.

Held at the end of day 1 of the MedTech22 Annual Conference, MTAA was proud to announce the winners in five award categories. Winners were chosen from a record number of high-quality entries, a testament to an industry that is developing and providing the Australian healthcare system with innovative solutions for patients.

Honouring Nicky Shalley and Warwick Kitt

A special mention to Nick Shalley and Warwick Kitt who were recognised as Honorary Life Members of MTAA at the 2022 Australian MedTech Industry Awards.

Nick Shalley was recruited into the role of MTAA industry representative on Clinical Advisory Groups (CAG) involved in the prostheses listing process. During his time as an industry CAG representative from 2005 to 2022, Nick participated in three CAGs: Urogenital, Vascular and Cardio-Thoracic. Nick also represented MTAA on the Prostheses List Advisory Committee (PLAC) and chaired Medical Technology Industry

Code of Conduct Authority for two years in 2016 to 2017 guiding the Association through challenging times.

Warwick Kitt began his senior leadership level involvement with MTAA (MIAA at the time) since 2001 when he was Managing Director of Alcon. He has been an active supporter of MTAA's policy development and an advocate of the Association's lobbying efforts and repeatedly made available his highly qualified staff to fill demanding leadership roles in the MTAA committee network. Warwick was recruited into the role of MTAA industry representative on Clinical Advisory Groups (CAG) involved in the prostheses listing process. During this time, he participated in five CAGs: Cardiac, Cardio-Thoracic, Hip, Spinal, and Ophthalmic. Warwick has served the MedTech industry in a number of capacities over two decades of significant change showing exceptional commitment.

Kerrie Rennie

The Kerrin Rennie Award was established in 2007 to recognise and profile the innovation and extraordinary contribution of medical technology in improving health outcomes of patients. This year's award was won by Smartz Limited for their Smartz technology - a wellness monitor in the form of a smart diaper. The Smartz solution addresses a significant unmet need in aged care providing real-life, evidence-based management of incontinence for the over 70% of aged care residents who are suffering with the condition. A printed ink sensor is incorporated into the standard manufacturing process of the diaper which then communicates with the cloud via a small reusable pod. The smart diaper notifies the carer when the diaper needs to be changed. It also notifies when the resident has been lying in the one position for too long and when they fall.

The device has also been reported to significantly improve in the skin integrity of the residents as they were no longer left for long periods of time in wet diapers reducing the risk of incontinence associated dermatitis (IAD) and UTIs. The Smartz diaper is an innovative example of how technology is improving the quality of life for Australia's growing aged care population and worthy winner of this year's Kerrin Rennie Award.

Outstanding Achievement

The Outstanding Achievement Award is open to individuals who have contributed in a significant way to the development of the medical technology industry through improvement to patient outcomes or excellence in leadership and innovation. This year we recognise, Professor Lyn Griffiths, Queensland University of Technology, for her support to the MedTech industry over the many partnering with industry to translate research outcomes to improve patient outcomes. She has collaborated with industry in the test and trailing of devices for MedTech companies such as Corbett Research, Medigard and Biomolecular System. She played a significant role in the establishment of the Johnson & Johnson Innovation Partnering Office and in partnership with State government and Johnson & Johnson Innovation to support life sciences start-up companies in Queensland. More recently,

Lyn has made a significant contribution to the development and delivery of research commercialisation training for researchers and entrepreneurs through the BridgeTech Program – a program to enable Australia to capitalise on the world class medical technology and device research sector more effectively by providing mid-career and senior life science entrepreneurs and scientists with relevant commercialisation training.

Women in MedTech Champion

Women in MedTech is a Board-led initiative which started in July 2015 in response to the gap of women in leadership positions across the industry. The support and engagement on this issue from members of industry has been overwhelming, making it a clear issue of importance for MTAA to support. The Women in MedTech Champion is awarded to an individual and a company who has contributed to advancing the mission and goals of Women in MedTech Committee.

Women in MedTech Individual Champion

This year's Champion individual winner was Lucimar Nielsen of Bard BD. Lucimar has proactively setup a professional network between nursing staff from urban and regional cancer centres with cancer patients across the country. This work support centres to exchange valuable information and improve access to patient care, especially in remote communities. Lucimar has also trained hundreds of oncology nurses in 'best practice' on the care and maintenance of central venous access devices and acute and chronic drainages. She helped to establish the Hospital-in-thehome treatment of pleural effusion for the Peninsula and Geelong regions by setting up their protocols and policies as well as training community nurses to optimally and confidently care for palliative care patients, keeping them in the comfort of their home and relieving any pressure from hospital admissions.

Women in MedTech Company Champion

The Women in MedTech Company Champion was awarded to Medtronic Australasia for their continuous improvements and commitment to female participation and leadership in MedTech.

In March 2022, Medtronic were named by as an Employer of Choice for Gender Equality recognised by WGEA (Workplace Gender Equality Agency) - the Australian Government's statutory agency that promotes and improves workplace gender equality. In receiving the above achievements and external recognition, Medtronic focused on specific activities and programs to help advance the MTAA WiMT

agenda including mentoring and sponsorship programs to support potential talent and build aspiring female leaders.

Medtronic have also demonstrated greater adoption of flexible working across the organisation, enhanced education among employees and managers about gender bias; reviewing and revising policies and practices that may perpetuate bias; and further standardising pay and rewards planning for all employees regardless of gender. Furthermore, they publicly declared their commitment by aiming to increase female representation in all levels of leadership in the organisation, with a target of 45% by 2026 and a commitment to increase this by 1-2% year-on-year until this target is reached.

Women in MedTech – Emerging Women in Leadership

The WiMT Emerging Women in Leadership Award recognises an exceptional female leader who has taken on a career challenge, move or change, exhibited leadership qualities and has moved the industry forward. This year, we recognise Charlotte Taylor of Stryker. Charlotte is an experienced and passionate leader with proven track record as Stryker's Territory Manager.

Upon returning from maternity leave in 2017, Charlotte excelled in performance and was quickly promoted to Territory Manager after regularly exceeding expectations. She was awarded Hip Rep of the Year in 2018, inaugurated to Sales Excellence in 2019, a member of the 2019 Executive Council and was recognised as the JR Sales Rep of the year in 2019. Through her involvement with the Management Readiness Program, she led a small team in the northern NSW and QLD region. Her ongoing support and ambition grew the team, exceeding expectations, and resulted in her recent promotion of Regional Manager, Joint Replacement in 2022.

Charlotte's collaborative approach, team mentality, and product and patient focus has set her up for success in every step of her career and makes her a worthy winner of the 2022 Emerging Women in Leadership Award.

Regulatory Affairs for Medical Devices Workshop 27-28 October 2022

MTAA travelled to Melbourne to host an interactive workshop providing coverage of the medical device regulations in Australia. Using the same format as the Sydney workshop 2 months earlier, this event successfully housed 32 students over the 2-days with TGA, once again, hosting a detailed and thorough syllabus on Australian medical device regulation.





Sustainability: The UK MedTech Landscape 10 November 2022

Over 130 attendees registered for the introductory webinar on the impact of sustainability measures affecting the UK MedTech industry. The Association of British HealthTech Industries, ABHI (the UK's MedTech Trade Association), presented on sustainability requirements in relation to healthcare procurement in the UK providing effective learning on how companies are navigating these processes.








Current State of Gender Equality - An International Women's Day Networking Event 23 February 2023

Professional Development

Professional development training for the medical technology workforce is imperative to keep standards elevated, reduce risk and grow the knowledge base of MedTech professionals. The skill and engagement of the workforce is reflected in better medical outcomes for patients, longevity of staff retention and greater stability for industry.

MTAA is the recommended industry standard provider for Operating Theatre Protocols (OTP) training for visitors to the perioperative environment. In 2022-23, the professional development department experienced strong attendance with OTP training courses for the second consecutive year. A total of 170 individuals participated in the OTP introductory course and 918 individuals for the online update course.

To increase convenience for interstate participants and to better manage internal resources, all MTAA courses, including OTP training, adopted a completely virtual format to better meet the needs of the current working climate.

The new Code of Practice training (Edition 13), the most popular online course available by MTAA, was completed by 3,560 individuals. This is a key requirement for Full Members of the Association. The Compliance and Competition Course was completed by 182 individuals, a requirement for all industry representatives' part of MTAA's governing committees, forums and working groups.

In total, 5,125 participated in all MTAA training courses for 2022-23.



Women in MedTech

In 2015, the MTAA Board initiated the concept of Women in MedTech (WiMT), to lead the debate and promote the benefits of gender diversity in the workplace and within the Medtech Industry. The Board established a Women in MedTech Committee to proactively support women to unlock their potential.

The committee was well represented with 14 members of different gender, role and business types to support a structured working plan leveraging existing MTAA assets, resources and connections. LinkedIn advertising and face-to-face events continue to be the leading channels to promote WiMT activities reaching thousands of MedTech professionals.

A key event on the WiMT calendar was International Women's Day on 8 March 2023. The day highlighted the UN Theme Cracking the Code: Innovation for a gender equal future and brings to light innovation that supports new social, economic and cultural codes for a gender-equal future. MTAA interviewed Professor Fiona Wood – an aspiring female leader and trailblazer in the industry to discuss gender equality, her invention of the 'spray-on skin' technology, and her accomplishments as a surgeon and researcher for over 30 years. Her interview was circulated to over 7,000 individuals online.





To further support the International Women's Day, MTAA hosted a face-to-face event presented by Elizabeth Pettit from member company PPD Search. Adopting the IWD organisation's theme, Embrace Equality, brought together 47 business leaders and employees to discuss the current state of workplace gender equality and how employers are acting to advance gender equality.

Other face-to-face events included R U OK? Day and a session at the MedTech22 Conference on Inclusion, Diversity and Equity in Action: Reconciliation Action Plan.


Mentoring Program

WORKING WITH INDUSTRY COLLABORATION



Working to unite the industry and engage a broader range of stakeholders is a way to strongly articulate and demonstrate the value proposition of the medical technology industry to the Australian community. Collaboration strengthens MTAA itself in terms of leadership, representation and advocacy, as well as membership.

Clinical Translation and Commercialisation MedTech Program

MTAA is a program partner with MTPConnect,
Australia's life sciences innovation accelerator for
the medical technologies, biotechnologies and
pharmaceuticals sector, which delivers the Clinical
Translation and Commercialisation MedTech (CTCM)
program, a \$19.75 million initiative funded by the
Australian Government's Medical Research Future
Fund (MRFF). The CTCM program seeks to identify
and nurture high-quality medical device projects with
strong commercial potential under development by
start-ups and small-to-medium enterprises.

Round 1 of funding was completed in October 2022 with a \$7.2 million investment made to accelerate medical device innovations. MTAA members, Eudaemon Technologies and ARIA Research were among awarded projects receiving \$1.5 million each. Eudaemon Technologies received funding for clinical trials of its next generation condom project and ARIA

Research received funding for its non-invasive bionic vision system currently in the clinical trials stage as well.

Other CTCM Projects Round 1 Funding Awarded to:

- LBT Innovations: \$1,500,000 award for APAS
 Compact Development of a desktop device for automated microbiology culture plate reading and reporting.
- Navi Medical Technologies: \$1,239,187 award for Safer care for critically ill children clinical translation of a new medical device to place and monitor paediatric central vascular catheters.
- OncoRes Medical: \$1,500,000 award for the commercialisation of a diagnostic imaging system for cancer surgery.

Round 2 of funding was announced in July 2023.

BioMedTech Horizons Program

MTAA supported MTPConnect to deliver the BioMedTech Horizons (BMTH) program, an initiative of the Medical Research Future Fund (MRFF) launched in 2017. The BMTH program was designed to support research and development activities of small and medium enterprise businesses making innovative early-stage medical devices.

Across four funding rounds, the BMTH program has supported 49 medical technology innovations and significant progress has been made toward their commercialisation goals. Eleven of those products have reached the critical regulatory approval milestones and are available for use.

MTAA is proud to have initiated discussions that led to the development of the BioMedTech Horizons (BMTH) program. As an advocate for the medical technologies

sector in Australia, CEO Ian Burgess was pleased to be a founding member of the Steering Committee that provided direction for BMTH, as well as providing advice and governance support through each of the four rounds of funding.

BMTH is launching a second Impact Report in August 2023 to capture the outcomes of 38 innovations supported through the program from 2017 – 2023, building on the successes of round one projects, which were detailed in the first BMTH Impact Report published in November 2021. The new report will cover the second, third and fourth rounds of BMTH funding, which saw \$30.3 million awarded, leveraging an additional \$36 million in contributions from industry.



Australian Ethical Health Alliance

MTAA is a founding member of the Australian Ethical Health Alliance (AEHA). The Alliance aims to improve healthcare in Australia through articulation and affirmation of ethical principles that promote the interests of patients and consumers, enhance access to safe and effective healthcare, encourage ethical collaboration in the healthcare sector and build public trust. MTAA is working with 71 other health sector organisations to achieve these aims.



CODE OF PRACTICE INTEGRITY

The objective of the MTAA Code of Practice is to help build and maintain the trust and confidence of, and accountability to, all communities with whom MTAA members engage.

In January 2023, MTAA launched Edition 13 of the Code. The new edition is easier to navigate with features like built-in live links with the new easier-to-understand explanatory notes and an updated glossary. Importantly, Edition 13 also includes new guidance on the use of social media, websites, and other online platforms to share product information with healthcare professionals. Since its launch, Edition 13 has been downloaded 2,916 times.

Also in January 2023, MTAA released an updated Code training program (in part) to help members become acquainted with the new standards of compliance. During 2022-2023, 3,560 individuals completed the Code training program, and about half as many were in the process of doing so as of 30 June 2023.

Separately, the Code Monitoring Committee continued through the year its oversight of MTAA's Vendor Credentialling (AS 5182:2018) program. The AS 5182:2018 standard defines the requirements for the credentialling of healthcare industry representatives and service providers entering healthcare facilities for the purposes of conducting business. The primary goal of these requirements is to ensure patient health, safety, and confidentiality, and alignment with Australian national statutes applicable to healthcare industry representatives and service providers.

Eligible MTAA member companies are obliged, as a condition of membership, to adhere to the Vendor Credentialling standard.

WORKING WITH MEMBERS COMMITTEES

Active participation of members is essential to MTAA achieving success. This year saw more than 220 member representatives contribute to the work of MTAA committees, forums and working groups. MTAA forums and alliances have progressed key initiatives relevant to participating members.

Public Affairs Committee

The Public Affairs Committee (PAC) provides oversight of the Reimbursement, Regulatory and Industry Policy Committees, ensuring a coordinated and aligned strategy and communications approach to MTAA's activities. The PAC sets the advocacy direction for the MedTech industry, identifying and engaging with relevant stakeholders in healthcare policy decision making. The PAC sets the direction for MedTech industry advocacy by identifying and engaging relevant stakeholders in health policy decision-making. Over the past year the PAC has led the development, refinement and promotion of the Value of MedTech report as well as planning key advocacy responses for the industry with the Commonwealth Government.

Regulatory Affairs Committee

The Regulatory Affairs Committee (RAC) is responsible for supporting the strategic development and delivery of MTAA's regulatory policy priorities. The RAC is also the body that discusses the operational issues facing the association's members in their interactions with the Therapeutic Goods Administration (TGA) in meeting the regulatory requirements for supplying MedTech in Australia.

The RAC's other objectives are to develop regulatory focused strategic initiatives for the MTAA including:

- Reviewing the effectiveness of the regulatory system for MedTech in Australia,
- Contributing to MTAA's involvement with international regulatory organisations,
- Liaising with Commonwealth departments and industry associations in Australia and overseas,
- Providing advice on the professional development of regulatory staff in the medical technology sector.

WORKING WITH MEMBERS

COMMITTEES

Reimbursement Committee

The Committee met 6 times during the year. It continued its strong focus as an advisor to MTAA and the Board on Prostheses List (now Prescribed List or PL) reform. This included contributing to and reviewing the many submissions by MTAA in response to PL reform consultations.

The Committee formed multiple working groups throughout the financial year to consider policy issues and develop detailed responses.

The Committee also shared challenges with the PL listing process that could be raised with the Department.

The Committee also increased its focus on non-PL issues including a standing agenda item on digital health reimbursement and discussions on MBS issues and funding models.

Finance

The Finance Committee assists the Board in the effective discharge of its responsibilities for financial reporting, internal controls, audit, compliance and risk management.

Industry Policy Committee

The role of the Industry Policy Committee (IPC) is to promote initiatives (outside regulatory and reimbursement) which impact on industry development and sustainability and healthcare policy.

Code Authority

The Code Authority Committee reports to the Board. Its primary function is to review Code complaints and provide advice and direction to the Code Monitoring Committee.

The Committee is headed by an independent chair, and consists of two board members, a healthcare professional, a consumer representative, seven industry representatives, and MTAA staff members.

Code Monitoring

The Code Monitoring Committee reports to the Code Authority Committee. Its primary function is to review monitoring reports submitted by MTAA members to ensure ongoing compliance with the Code of Practice.

The Monitoring Committee is headed by an independent chair, and consists of an independent chair, a consumer representative, seven industry representatives, and MTAA staff members.

MedTech Conference

This committee drives the agenda, sponsorship and attendance of the Annual Conference to ensure it appeals to MedTech industry leaders and executives.

Women in MedTech

The Women in MedTech Committee was established to drive and fulfil several objectives, including to continue to promote the WiMT initiative to the wider MedTech industry. Despite challenges in the workforce due to the pandemic, MTAA organised a number of WiMT initiatives as part of its objective to raise the profile and benefit of women within the MedTech industry through their mentoring program, targeted campaigns and events.



WORKING WITH MEMBERS FORUMS

Regulatory Forum

The Regulatory Affairs Forum is an extension of the Regulatory Affairs Committee (member base is large and covers a range of members) and acts as an information-sharing space to ensure the broad membership is covered and issues are passed up to the committee and subsequently to the TGA and RegTech Committee.

Reimbursement Forum

The Forum was instituted in 2022 to provide updates on important reimbursement issues, including PL reforms, to a wider group than the formally nominated Reimbursement Committee. The Forum typically met within two weeks of Reimbursement Committee meetings. The majority of its meetings involved providing updates on the complexities of PL reforms with participants having the opportunity to answer questions. The mailing list grew to over 70 while typical attendance was over 30.

Clinical Investigations Forum

The Clinical Investigations Forum comprises of MTAA member companies who conduct Clinical Trials in Australia. The forum allows important information to be shared to ensure arising issues are identified and actioned through the MTAA Industry Policy Committee and the Research & Development Task Force and acts as an educational conduit amongst the broader MTAA membership.

Cardiac Forum

The Forum is a collaboration of five cardiac rhythm device companies primarily intended to address the issue of funding for cardiac technical support services associated with cardiac implantable electronic devices in the context of PL reforms. The Forum has met weekly through the year and at the request of the Department of Health and Aged Care made a joint submission to the Medical Services Advisory Committee on the value and funding for these services.

The Forum has also engaged with multiple stakeholders including the Department on related issues.

Neuromodulation Forum

The Forum is a collaboration of 8 companies with neurostimulation devices with the goal of discussing and responding to common policy and environmental issues.

The Forum meets on an ad hoc basis approximately monthly. Key focus areas included regrouping of items on the Prostheses List (now the Prescribed List), post-listing review of PL items which included a joint submission to the Department of Health and Aged Care, and engagement with consumer and clinician groups on advancing treatment related involving neurostimulation.

Ophthalmic Forum

The Ophthalmic Forum brings together member non-member companies to understand the latest policy developments from the Department of Health that will directly impact ophthalmic companies. The main focus of the group has been understanding and responding to the latest PL reforms. MTAA has been able to provide informative updates on the reforms regarding the PL regrouping processes. PL listing and removal reforms, and the implementation of the Health Products Portal.

In addition, the forum has also been able to develop responses to some of the reforms proposed by the Department of Health under the banner of MTAA such as the PL regrouping process and feedback on the new Prescribed List consultation guide. The forum continues to meet on a regular basis to monitor any changes.

SME Forum

The SME forum is a space for the smaller members of MTAA to come together to provide input on key policy areas that more directly impact smallest size companies. The main positive has been linking SMEs to other key working groups and forums, where useful information can then be applied to their own business practices.

In addition, the Forum provides a space within MTAA to unify the voice of smaller members, allowing for their contribution to broader industry wide advocacy initiatives. The most notable of these has been the Value of MedTech report, where smaller companies provided key data to be included in the report.

Going forward, the main focus will also be to host an SME event where the aim would be to connect a large hospital group with a delegation of SMEs to better understand the services that SMEs provide. In addition, the event will also help SMEs understand how hospital groups want to work more effectively with suppliers going forward.

Orthopaedic Forum

The MTAA Orthopaedic Forum provides members with the opportunity to discuss and address issues of mutual interest and concern to those companies involved in the orthopaedic sector, in an environment respectful of competition values.

The Forum offers collective linkages to the Australian Orthopaedic Association in circumstances where an industry voice is more appropriate and provides AOA members the opportunity of being abreast of significant industry issues and activities. The output of the MTAA Orthopaedic Forum also informs relevant MTAA committees and provides the MTAA Secretariat with aggregated input on key industry policy matters.

The orthopaedic sector has continued to provide much needed implant supply support to surgical procedures across Australia in both the public and private sectors. Companies offer orthopaedic technicians' support in theatre in the manner required and preferred by surgeons and hospitals.

The forum meets quarterly and is open to membership by all MTAA companies supplying orthopaedic products, with discussion targeted at the CEO level.

Twenty member companies participate in the activities of the Forum. Regular activities include:

- Scheduled meetings with the Australian
 Orthopaedic Association (AOA) Presidential Line,
 the AOA CEO and the Director of the AOA National
 Joint Replacement Registry, are usually held
 quarterly.
- MTAA works closely with KPMG in the conduct of the MTAA Orthopaedic Market Survey. The survey has 17 companies contributing data in the categories of hips, knees, shoulders, spine, trauma, sports and bone cement products with six-monthly aggregated data reports being shared amongst contributors.
- Ad hoc meetings to discuss Prostheses
 List regrouping proposals prepared for the
 Department of Health and Aged Care.



WORKING WITH MEMBERS WORKING GROUPS

Advertising Working Group

The MTAA Advertising Working Group is comprised of representatives of member companies from regulatory, communications and marketing areas who are involved with advertising activities within their companies. The Advertising WG had over 30 members in FY2022/23 and provided input and recommendations in resolving current regulatory challenges with advertising of medical devices.

Cyber Security Working Group

The MTAA Cyber Security Working Group (CSWG) aims to bolster the medical technology sector's position as a leader in cyber security. Through stakeholder engagement with relevant government bodies (TGA, ACSC, state governments) and structured partnerships across the healthcare and cybersecurity sectors, the CSWG facilitates the development of improved practices, and policy development for of healthcare based cyber security.

Digital Health Advisory Group

The Digital Health Advisory Group is comprised of MTAA members and non-members (including representatives from academic institutions, the Australasian Telehealth Society etc.) and aims to become a partner with the Australian Government to improve digital healthcare in Australia and to develop advocacy and policy positions relevant to MTAA members that manufacture medical devices with monitoring capabilities.

Industry Development Working Group

The Industry Development Working Group, formerly known as the Manufacturing Working Group, has been reactivated and has been key in progressing key industry policy positions. The main focus of the working group has been to develop an industry position in response to the National Reconstruction funds \$1.5 billion allocation to medical manufacturing. MTAA developed an extensive submission that was then submitted to the Department of Industry.

This has helped MTAA join the Medical Sciences Industry Working Group that will be developing the coinvestment plans within the National Reconstruction Fund for the medical sciences priority area. In addition, the working group has also been able to provide feedback on other key consultations, such as the 'List of Critical Technologies in the National Interest' consultation paper, which provided a list of critical technologies that the department initially could refer to in terms of future political policy development and investment.

Radiation Therapy Advisory Group

An alliance of cancer patient advocates, healthcare providers, MedTech vendors and oncology professionals aligned, the Radiation Therapy Advisory (RTAG) Group in responsible for raising the profile of radiation therapy and ensuring it is adequately funded by government.

While radiation therapy and many different specialised treatments it involves are not always simply to understand, the RTAG is able to bridge this knowledge gap by providing highly informed and expert advice to decision and policymakers.

Research Development Taskforce

The RDTF is a multi-sector collaboration between MTAA, AusBiotech and Medicines Australia. The membership consists of research and development experts, particularly in clinical trials, and offers a unique industry perspective to stakeholders across Federal and State Governments as well as the broader health and research and development sector.

In 2022-23 the taskforce undertook work to support the Australian Teletrial Program, ACTA - International Clinical Trial Symposium: Industry Engagement, VCCC Alliance Skilled internship program and the ATHENA program in Queensland. Additionally, the taskforce also worked on the National One-Stop Shop, Recycling and Reusing Clinical Trials supplies and Patient Recruitment Clinical Trials Webinar/Campaign.

Supply Chain Working Group

The Supply Chain Working Group was formed in the second half of 2022 - with the aim of having a group of members that can engage key government stakeholders on supply chain matters and also develop policy positions on key supply chain managers for industry. The working group has been key in helping shape the MTAA supply chain survey that was sent out in August last year to members. This resource provided a snapshot of the barriers and enablers for doing business in Australia post COVID.

The working group has also been useful in providing a real time assessment of any supply chain challenges that might be affecting medical device companies. The information from the working group has been useful as updates to the Office of supply chain resilience roundtables, of which MTAA is a representative. Increasing focus on supply chain aligns with MTAA's broader strategic plan to focus on supply chain resilience over the next few years.
